## Dear Minister

Southern Grampians Shire Council is seeking support for processing of kangaroo meat within the State of Victoria and in particular South-West Victoria.

At present, the culling of kangaroos by licensed shooters is legal in Victoria but processing kangaroo meat is prohibited. It is Council's understanding that such processing is permitted in other States of Australia.

The concern for Southern Grampians Shire Council is that the inability to process meat for pet food or any other purpose denies the State employment and business opportunities whilst at the same time creating a waste and environmental issue. Without opportunities to process the meat, kangaroo carcasses are left lying in paddocks to rot. This poses issues of odour problems and increased feral animal and vermin infestation. In a world where available resources are finite and consumption rates are increasing, this is illogical, especially given that culling is permitted legally.

As you can see from the attached letters of support, surrounding Shires in the south west of Victoria support Southern Grampians Shire's policy position. These four shires collectively represent 22,942 square kilometres of rural land.

I urge the State Government of Victoria to reconsider its policy against the efficient and environmentally-sensible use of these kangaroo carcasses.
