

PREPARATION OF BUDGET FOR 2017/18

In accordance with Section 129 of the Local Government Act 1989, the Southern Grampians Shire Council, at its meeting held on 24 May 2017, resolved that the Budget presented to that meeting be prepared.

Section 223 of the Local Government Act 1989 provides that any person may make a submission on any proposal contained in the Budget or the declaration of rates and charges must do so in writing by 5.00pm on **Monday 26 June 2017**. Submissions, should be addressed to:

Persons making submissions are requested to indicate whether they wish to be heard in support of their submission and whether they will attend in person and/or be represented by some other person.

Any submissions received will be heard at a Special Meeting of Council to be held in the Hamilton Library, 109 Brown Street, Hamilton on Monday 3 July 2017 at 5.30pm.

Following this meeting, all submissions received in writing and in person, will be considered by Council.

Adoption of the 2017/2018 Budget and declaration of rates and charges for 2017/2018 will be considered at a Special Meeting of Council to be held in the Council Chambers, 3 Market Place, Hamilton on **Wednesday 12 July 2017**.

Submitters should note that Council is required to make available for public inspection submissions received in accordance with Section 223 for a period of 12 months.
