## Fair Access Action Plan 2024

Southern Grampians Shire Council are supportive and committed to doing our part in ensuring our recreation and sport facilities, user groups, clubs and Council are inclusive and safe spaces for women and girls. This Southern Grampians Shire Council Fair Access Action Plan has been developed to support the integration of Fair Access Policies and Principles the State Government had introduced in a new policy, and to convey Council's ongoing commitment to ensure the facilities we provide are inclusive and welcoming to women, girls and other gender diverse persons.

Southern Grampians Shire Council acknowledges that this action plan and Fair Access Policy has been created under the direction of the State Government to be relative mostly to women and girls, however these principles we intend to extend to the other gender diverse community and Council strives to create opportunities and spaces where all people feel safe and welcome regardless of how they identify.

The Fair Access Action Plan has been developed with an understanding that timeframes can change in relation to the timeframes of implementation, and that DEECA reserves cannot have Council's Fair Access Policy or Action Plan enforced upon them. These DEECA reserves are captured in the Fair Access through the new requirements when applying for and receiving our Community Grants. This plan ensures continued actions from Councils' Gender Equality Action Plan 2021-2025, and will also target Council's recreation/sporting facilities and user groups more specifically.

The table that follows outlines the steps in which Southern Grampians Shire Council will take to implement Fair Access across the Shire, the expectations of Council's user groups and the Fair Access Principles the actions align with.

The timeframes are as follows:
