Fairfield is a single storey asymmetrical timber house with a corrugated iron verandah supported by carved timber posts. The house was originally a timber house of six rooms with gable roofs and a small verandah enclosing a porch. Four rooms have been added to the original house in the 1930s.

The house is set is set in a substantial Edwardian garden, with typical plantings and features. A circular lawn is located at the front of the house with a Canary Island Palm (Phoenix caneriensis) planted at the centre, gravel driveways and various other plantings of Canary Island Palm dominate the front garden and dwarf the house. The house and garden are surrounded by a hedge of Lawson's Cypress Cupressus lawsoniana which has been trained into an arch over the driveway with a smaller convex arch above it.

The land on which Fairfield stands was first taken up by H. Henty & Co. in 1870 as allotment 4B of Section C in the Parish of Jennawarra. H. Henty and Co. also took up several other allotments, including 2B and 3B of section C. Many other Hentys, including Stephen George Henty took up much of the land in the Parish of Jennawarra after the Land Selection Acts of the 1870s (Department of Lands and Survey, 1880). The exact connection between H. Henty and Co. and Stephen George Henty is, but he had a daughter named Ellen (also known as Helen), and the Henty & Co. business was still operating at this time. This may have been a typical example of a squatter 'dummying' selector claims in order to purchase as much land as possible.

Johann Mibus later purchased various allotments of the Warrayure estate when it was subdivided and offered for sale in the 1880s. The intention was that his youngest sons, Theodor and Emil would share the home property, Hope Park, while the elder sons, Alfred, Carl, Adolph, Otto, Ernst, Heinrich and Gottlieb would take up the land at Warrayure independently (Nagorka, 42).

Johann and Dorothea Mibus arrived in Australia from Prussia in 1847 with a number of other German Lutheran families. They arrived in South Australia, and established a settlement in the Barossa Valley named Hoffnungsthal immediately after (Nagorka, 15). The settlement at Hoffnungsthal was not successful, and in 1855, the Mibus (or Miebus) family, along with Johann and Christine Huf decided to migrate to Victoria, where they landed at Portland (ibid., 20). They went inland, and arrived at Hochkirch-with their family of seven children.

They took up land which they had selected, which is now known as Hope Park, on the Chatsworth Road, east of Hamilton, where their family continued to grow. Otto Mibus was their sixth son, and was born at Hope Park in 1882 (Nagorka, 249). After completing his schooling at the Hochkirch Lutheran school he worked with his elder brothers on the family property at Hope Park. In 1907, a parcel of land on the northern side of Lake Linlithgow was purchased by Johann Mibus to divide between his sons Otto and Gottleib in order for them to establish their own farms. Nagorka (249) describes the site which Otto took up (now Fairfield) as "an open paddock without trees or buildings, so bleak that the water bucket had to be tied to a peg outside the camp hut or it would be blown away".

The land was worked, but Otto continued to be based at his family home in Tarrington until 1912, when he built a six roomed timber house, at a cost of three hundred pounds. The following year he married Meta Schurmann, a granddaughter of the famous Pastor Schurmann (ibid.). Otto ran Fairfield as a mixed farm, growing fine and superfine wool as the main income, eventually diversifying into Oats for hay and grain, which did well on the land adjacent to the Lake. The growing family of Otto and Meta led to an addition of four rooms to the house in 1930 (ibid.).

There has been no architect or builder associated with the design of the house or the garden. The house is located in a typical Edwardian garden with several fine specimens of Canary Island Palm (Phoenix canariensis). The land was purchased by Johann Mibus as one of several parcels of land he purchased from the Warrayure Estate in the 1880s. Each of the allotments was given to one of his seven sons to farm independently. Otto Mibus, the sixth son of Johann Mibus took up the land and built a six room timber home in 1912. His growing family demanded the extension of the house by four rooms in 1930. The house is in good condition and retains a good degree of integrity to the 1930s period. How is it significant? Fairfield is of historical significance to the Southern Grampians Shire. Fairfield is of historical significance for its associations with the Mibus family, who have had continuous ownership of the property for almost 100 years. It is of further historical significance when viewed with other properties which were developed by the sons of Johann Mibus on the land which he purchased from Warrayure Estate to assist his children in establishing independent livelihoods.
